Condition: You are given an AN/PDR-77 Radiac Set, flat-tip screwdriver, batteries, Technical Manual (TM) 11-6665-365-12&P, and a requirement to put the Radiac Set into operation to monitor for radiological contamination. Some iterations of this task should be performed in MOPP 4.

Standard: Operate the AN/PDR-77 Radiac Set under usual conditions by performing Preoperation, Operation, and Post-operation procedures in accordance with the operator manual. Reads and follows all safety notes, and performs all procedures without injuring self or others, or damaging the AN/PDR-77 Radiac Set.

Performance Steps

1. Perform preoperation procedures IAW the operator's manual.
 - a. Read and adhere to all safety notes and requirements.
 - b. Inventory equipment for completeness.
 - c. Ensure sufficient number of batteries are on-hand to complete the mission.
 - d. Perform all before operation checks, services, and tests.
 - e. Configured the equipment for operation.

2. Perform operation procedures IAW the operator's manual.
 - a. Read and adhere to all safety notes and requirements.
 - b. Perform start-up procedures.
 - c. Employ the equipment to perform the desired operational procedure (i.e. monitor, detect, sample, etc.)
 - d. Perform during operation checks, services, and tests.

3. Perform post-operation procedures IAW the operators manual.
 - a. Read and adhere to all safety notes and requirements.
 - b. Perform shut-down procedures.
 - c. Perform after operation checks, services, and tests.

(Asterisks indicates a leader performance step.)

Evaluation Guidance: Read the action, conditions, and standards to the Soldier. Tell the Soldier that he will be assessed on his ability to perform the task using a GO/NO GO rating system. Inform him that to receive an overall GO on the assessment, that he must receive a GO on each of the task's Performance Measures. Provide the Soldier with the prior prepared 5X8 scenario card. While the Soldier is performing the task provide additional scenario, and simulated guidance as necessary for the Soldier to complete the task (i.e. when the Soldier begins to take a dose rate reading at a point of interest, you could tell him that his monitor displays a reading of 6 cGy/hr).

Evaluation Preparation: Gather all items in the task's conditions statement (AN/PDR-77 Radiac Set w/Operator's TM, batteries, etc.) and place them on a table. Prepare a 5X8 card with a scenario on it that cues the Soldier to perform all task steps. For example: "You are a member of a CBRN Survey team that has been given a mission to perform a Ground Radiological Survey of a point of interest. You are told that you are the team's designated radiation monitor. To prepare for the mission you must perform preoperation procedures on your AN/PDR-77. Your duty during the survey mission is to determine if X-Ray radiation is present at the point of interest and at what level. After the mission is complete you must perform post-operation procedures on the AN/PDR-77."

Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW FM 3-11.4, Multiservice Tactics, Techniques, and Procedures for Nuclear, Biological, and Chemical (NBC) Protection, FM 3-11.5, Multiservice Tactics, Techniques, and Procedures for Chemical, Biological, Radiological, and Nuclear Decontamination.
