Environment: Environmental protection is not just the law but the right thing to do. It is a continual process and starts with deliberate planning. Always be alert to ways to protect our environment during training and missions. In doing so, you will contribute to the sustainment of our training resources while protecting people and the environment from harmful effects. Refer to the current Environmental Considerations manual and the current GTA Environmental-related Risk Assessment card. Risk Management (RM) is the Army's primary decision-making process for identifying and controlling hazards across all missions, functions, operations and activities. Leaders must excel at evaluating operational and tactical hazards through the synchronizing of RM with the planning, prioritizing and analyzing phase of Mission, Enemy, Terrain and Weather, Troops, Time Available, and Civil Consideration (METT-TC) and will complete a DD Form 2977, Risk Assessment worksheet during the planning of each task and sub-task. TRADOC Regulation 350-29, Prevention of Heat and Cold Casualties, must be included on risk assessments, adhering to figures B2 and C2 and local Fort Jackson Heat Injury Prevention protocols or Joint Base Little Creek (JBLM) procedures. In response to COVID-19, the Department of Defense and Fort Jackson have elevated the Health Protection Conditions to Charlie plus adding "tactical dispersion" recognizing that a substantial and sustained community transmission risk exists. These measures will be included on risk assessments. Commanders will embed RM into all mission orders and briefings for review by the senior leaders to ensure proper controls are in place.

Safety: In a training environment, leaders must perform a risk assessment in accordance with current Risk Management Doctrine. Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW current CBRN doctrine. Everyone is responsible for safety. A thorough risk assessment must be completed prior to every mission or operation.
