5. Coordinate with a World Religions POC to ensure analysis is well supported.
6. Organize by PMESII-PT as related to religion:
  - a. Political and Religion.
  - b. Military and Religion.
  - c. Economic and Religion.
  - d. Social and Religion.
  - e. Infrastructure and Religion.
  - f. Information and Religion.
  - g. Physical Environment and Religion.
  - h. Time and Religion.
7. Present measurable trends in a 8-10 slide PowerPoint Presentation.

  - a. Organize analysis by operational variables.
  - b. Identify RFIs focused on what you don't know, but need to know.

**Environment:** Environmental protection is not just the law but the right thing to do. It is a continual process and starts with deliberate planning. In doing so, you will contribute to the sustainment of our training resources while protecting people and the environment from harmful effects. Refer to the current Environmental Considerations manual and the current GTA Environmental-related Risk Assessment card. Environmental protection is a continual process. Always be alert to ways to protect our environment and reduce waste.

**Safety:** In a training environment, leaders must perform a risk assessment in accordance with current Risk Management Doctrine. Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW current CBRN doctrine. Everyone is responsible for safety. A thorough risk assessment must be completed prior to every mission or operation.
