Condition: The staff officer receives new members to the staff, is new to the staff, or must realign the staff and/or command post for operational reasons. The staff officer receives guidance from the commander on staff organization and command posts for operations. The command establishes communications with subordinate and adjacent units, and higher headquarters. The mission command system is operational and processing information in accordance with standard operating procedures. Some iterations of this task should be performed in MOPP 4.

Standard: The staff officer validates the maneuver warfighting function staff by verifying adherence to the standard operating procedures to meet the commander's intent, orders from higher, and operational requirements.

Notes: The term 'staff officer' refers to the unit Chief of Staff (CoS), Executive Officer (XO), Deputy Commanding Officer (DCO), and/or another designated officer as directed by the commander.

Note 2: This task is a subordinate task to 150-718-0000 (Organize the Staff) in which the staff officer conducts the initial duties of the CoS, XO, and/or DCO. Before executing this task the staff officer should execute task 150-718-0000.

Performance Steps

1. The staff officer confirms proper manning of the maneuver warfighting function staff in accordance with the commander's intent, orders from higher, operational requirements, and unit manning rosters.

2. The staff officer confirms that the maneuver warfighting function staff conducts basic initial staff duties and assumes responsibilities to include:

- a. Informing the commander of all mission related staff tasks.
- b. Developing and maintaining running estimates.
- c. Providing recommendations.
- d. Preparing plans, orders, and other staff writing.
- e. Assessing operations.

3. The staff officer organizes, manages, monitors, trains, and inspects the maneuver warfighting function as specified in FM 7-15, The Army Universal Task List C-10 (February 2009):

a. ART 1.1 – Perform Tactical Actions Associated with Force Protection and Deployment.

- (1) Conduct mobilization of tactical units.
- (2) Conduct tactical deployment and redeployment activities.
- (3) Conduct demobilization of tactical units.
- (4) Conduct rear detachment activities.

b. ART 1.2 – Conduct Tactical Maneuver.

- (1) Conduct one of the five forms of maneuver.
- (2) Employ combat formations.
- (3) Employ combat patrols.
- (4) Conduct counter ambush actions.
- (5) Exploit terrain to expedite tactical movements.
- (6) Cross a danger area.
- (7) Link up with other tactical forces.
- (8) Conduct passage of lines.
- (9) Conduct a relief in place.
- (10) Navigate from one point to another.

(11) Conduct a survivability move.

(12) Conduct sniper active countermeasures.

(13) Conduct sniper passive countermeasures.

c. ART 1.3 - Conduct Tactical Troop Movements.

(1) Prepare forces for movement.

(2) Conduct tactical road march.

(3) Conduct tactical convoy.

(4) Conduct an approach march.

d. ART 1.4 – Conduct Direct Fires.

(1) Conduct lethal direct fire against a surface target.

(2) Conduct nonlethal direct fire against a surface target.

e. ART 1.5 – Occupy an Area.

(1) Occupy an assembly area.

(2) Occupy an attack and assault position.

(3) Occupy and establish a battle or defensive position.

(4) Conduct drop zone operations.

(5) Conduct landing zone operations.

f. ART 1.6 - Conduct Assured Mobility.

(1) Overcome barriers, obstacles, and mines.

(2) Enhance movement and maneuver.

(3) Negotiate a tactical area of operations.

(4) Provide diver support.

(5) Conduct nontactical movements.

g. ART 1.7 - Conduct Countermobility Operations.

(1) Site obstacles.

(2) Construct, emplace, or detonate obstacles.

(3) Mark, report, and record obstacles.

(4) Maintain obstacle integration.

h. ART 1.8 - Employ obscurants.

i. ART 1.9 - Conduct maneuver support operations.

4. The staff officer produces required changes, updates, or augmentations (in accordance with the commander's guidance and unit standard operating procedures (SOP) based on inspection results.

Note: The staff officer inspects individuals, teams, and cells.

5. The staff officer briefs the commander on deficiencies and readiness status according to the commander's guidance and unit SOP.

(Asterisks indicates a leader performance step.)

Evaluation Guidance: Score the Soldier GO if he/she passes all performance measures. Score the Soldier NO-GO if Soldier fails any performance measure. If the Soldier scores NO-GO, show the Soldier why he/she failed and show the Soldier how to perform the measure correctly.

Evaluation Preparation: Brief the Soldier: Explain expectations to the Soldier by reviewing the task standards. Stress to the Soldier the importance of observing all cautions and warnings to avoid injury to personnel and, if applicable, damage to equipment.

Consider the MOPP work/rest cycles and water replacement guidelines IAW FM 3-11.4, Multiservice Tactics, Techniques, and Procedures for Nuclear, Biological, and Chemical (NBC) Protection, FM 3-11.5, Multiservice Tactics, Techniques, and Procedures for Chemical, Biological, Radiological, and Nuclear Decontamination.
