Conditions: The Theater Sustainment Command (TSC) has deployed to theater and directed the FISC to maintain Finance Information Systems (FIS). The FISC is supporting forces engaged in large scale combat operations (LSCO) across multi-domain operations. The FISC collects, processes, stores, displays, disseminates, and protects knowledge products, data, and information to exercise oversight. All deployed FIS are operational and loaded with current software. Data inputs created by FISC staff elements and received from continental United States and theater finance support elements are uploaded and provided to the Director, FISC and other staff officers/activities as required. The finance systems section has established alternative methods of communication in the event access to FIS is denied, degraded, and disrupted. Connectivity to the Non-Classified Internet Protocol Router Network / SECRET Internet Protocol Router Network (NIPRNET/SIPRNET) is established. The Financial Management Tactical Platform (FMTP), and other FIS and software are employed in support of operations. The FISC conducts operations in a dynamic and complex operational environment (OE) against a peer threat. Local standard operating procedures (SOP), AR 25-1, AR 380-5, DODFMR 7000.14-R and FM 1-06 are available. Conventional attacks by hostile aircraft and operations by ground elements are possible. Threat capabilities include space and cyber space operations that degrade sustainment information system capabilities as well as employment of conventional, special operations, guerrilla, and insurgent forces to interdict friendly air, land, and maritime operations in a Chemical, Biological, Radiological, Nuclear and high yield Explosive (CBRNE) environment. Some iterations of this task should be performed in MOPP 4.

**Standards:** Ensure all data is uploaded and downloaded with 100 percent accuracy. Specified financial reports are provided within established timelines and in accordance with (IAW) DODFMR 7000.14-R. Access to FIS equipment is restricted to authorized personnel. FIS security practices, policies, and procedures are established and applied.

Based on the FISCs authorized strength, to obtain a T rating, 75% of the Finance Systems Section leaders and 80% of Soldiers are present at training. The FISC Finance Systems Section attains 80% on performance measures, 100% on critical performance measures, and 85% on leader performance measures.

Leaders are defined as FISC Director and Chief, Finance Systems Section.

**Environment:** Environmental protection is not just the law but the right thing to do. It is a continual process and starts with deliberate planning. Always be alert to ways to protect our environment during training and missions. In doing so, you will contribute to the sustainment of our training resources while protecting people and the environment from harmful effects. Refer to the current Environmental Considerations manual and the current GTA Environmental-related Risk Assessment card. It is the responsibility of all Soldiers and Department of the Army Civilians to protect the environment from damage.

Safety: In a training environment, leaders must perform a risk assessment in accordance with current Risk Management Doctrine. Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW current CBRN doctrine. Safety in performing tasks and within the work/task environment is everyone's responsibility. Supervisors and leaders must ensure a safe and healthful workplace by inspecting the area for hazards and promptly taking action as required to correct hazards. Leaders increase safety by ensuring that Soldiers and Army Civilians are trained and competent to perform their work safely, efficiently, and effectively. Counsel and take action as necessary with Soldiers or Army Civilians who fail to follow safety standards, rules and regulations, including the use of personal protective clothing and equipment, and seatbelts. Leaders should hold all personnel accountable for accidents and property damage, occurring in operations under their direct supervision and control. (See AR 385-10, The Army Safety Program).
