Performance Steps

1. Receive Component Commanders intent for mortuary affairs tasks in the operational environment (OE).
 2. Orient mortuary affairs planning to meet Component Commanders guidance.
 3. Review current agreements with host nation.
 4. Advise Component Commander on the following:
 - a. Mortuary affairs personnel requirements.
 - b. Mortuary affairs equipment requirements.
 - c. Requesting mortuary affairs assets by standard requirement code (SRC).
Note: See FM 4-20.64 for additional information on unit SRCs.
 - d. Developing time-phased force and deployment data (TPFDD).
Note: See FM 3-35, ch 2, para 2-4.
 - e. Flow of mortuary affairs asset into the OE.
Note: Joint Operation Planning and Execution System (JOPES) provides the mechanism to submit movement requirements to lift providers in the form of a TPFDD.
 - (1) Personnel movement by air.
 - (2) Equipment movement by sea.
 5. Request Mortuary Affairs Contaminated Remains Mitigation Site be moved to nearest Army prepositioned stocks (APS) location.
Note: See FM 3-35.1 ch 1, para 1-6 for more information.
 6. Advise Component Commander on requirements for Reception, Staging, Onward Movement, and Integration (RSOI).
Note: See FM 3-35 ch 4 for more information. Once RSOI is complete mortuary assets transition to operational assets.
- (Asterisks indicates a leader performance step.)

Evaluation Guidance: Score the NCO a Go if all steps are passed (P). Score the NCO a NO-GO if any step is failed (F). If the NCO fails any step, show what was done wrong and how to do it correctly.

Evaluation Preparation: Use a predetermined site. Provide the NCO with required personnel and equipment to perform the task. If mannequins will be used for training purposes ensure they are handled as actual fatalities.

Environment: Environmental protection is not just the law but the right thing to do. It is a continual process and starts with deliberate planning. Always be alert to ways to protect our environment during training and missions. In doing so, you will contribute to the sustainment of our training resources while protecting people and the environment from harmful effects. Refer to FM 3-34.5 Environmental Considerations and GTA 05-08-002 ENVIRONMENTAL-RELATED RISK ASSESSMENT.

Safety: In a training environment, leaders must perform a risk assessment in accordance with FM 5-19, Risk Management. Leaders will complete a DA Form 7566 COMPOSITE RISK MANAGEMENT WORKSHEET during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW FM 3-11.4, Multiservice Tactics, Techniques, and Procedures for Nuclear, Biological, and Chemical (NBC) Protection, FM 3-11.5, Multiservice Tactics, Techniques, and Procedures for Chemical, Biological, Radiological, and Nuclear Decontamination.
