**Conditions:**

The division receives a report of a civil disturbance within the area of operations. The commander issues guidance reacting to a civil disturbance in dynamic and complex operational environment (OE), against a hybrid threat, contesting the division's objectives in all five domains (land, sea, air, space, and cyberspace), the information environment, the electromagnetic spectrum (EMS), and throughout operations to achieve mission objectives. The threat maintains contact with the division in multiple domains. All eight operational variables of PMESII-PT are present. The order from higher headquarters includes all applicable overlays and/or graphics, area of operation (AO) boundaries, control measures, and criteria for subsequent tactical actions. All necessary personnel and equipment are available. The division is task organized with necessary units and reinforced with assets from higher to accomplish assigned tasks. The division has communications with subordinate units, adjacent units, and higher headquarters. The commander organizes the four components of the command and control (C2) system to support decision making, facilitate communication, and conduct operations.

Environment: Some iterations of this task should be performed with degraded C2 networks, degraded conditions in the EMS, and/or with a degraded, denied, and disrupted space operations environment.

This task should not be trained in MOPP 4.

**Standards:**

The division receives a report of a civil disturbance in the area of responsibility via command and control information systems and relays it immediately to unit chain of command, higher, lower, and adjacent units. The staff conducts hasty mission analysis in accordance with standard operating procedures and develops courses of action that meet the commanders intent, conform to local and international law, and follow rules of engagement. The execution of the plan limits loss of life, equipment and infrastructure. Reacting to a civil disturbance is conducted with 100% adherence to the commanders intent, orders from higher headquarters, the Army Ethic, ATP 3-39.33, and unit standing operating procedures (SOP) while adhering to the Go/No Go criteria.

**Drill Statements:**

**WARNING**

Follow guidelines within Unit SOP and local regulations.

**Safety:** In a training environment, leaders must perform a risk assessment in accordance with current Risk Management Doctrine. Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW current CBRN doctrine.

**Environment:** Environmental protection is not just the law but the right thing to do. It is a continual process and starts with deliberate planning. Always be alert to ways to protect our environment during training and missions. In doing so, you will contribute to the sustainment of our training resources while protecting people and the environment from harmful effects. Refer to the current Environmental Considerations manual and the current GTA Environmental-related Risk Assessment card. Follow guidelines within Unit SOP and local regulations.

**Cue:** The command post (CP) receives initial report of a civil disturbance in the area of responsibility via command and control information systems (C2IS).

**Note:** Follow guidelines within Unit SOP and local regulations.

**Coaching Point:** Ensure SOP is current. Continue to rehearse this drill until the staff has mastered all steps within the drill.

## TASK STEPS

1. The staff member who receives the initial report of a civil disturbance immediately informs the current operations integration cell Battle NCO/Officer, in accordance with unit standard operating procedure (SOP), who will:
  - a. Inform battle captain.
  - b. Record entry into event log on command and control information system (C2IS).
  - c. Monitor for follow-up reports.
  - d. Maintain communications with reporting unit in order to obtain the information in the following format: size, activity, location, unit, time, and equipment (SALUTE).
  - e. Establish primary and secondary means of communication for maintaining contact with reporting unit.  
Note: Primary, alternate, contingency, emergency (PACE) communication is in accordance with unit SOP.
2. The current operations integration cell battle captain, in accordance with unit SOP, completes the following actions:
  - a. Inform G-3 and/or chief of current operations integration cell, higher headquarters (HQ) and all major subordinate commands of the civil riot or incident via C2IS.
  - b. Direct liaisons of units affected by the incident to continue to gather and relay information.
  - c. Direct non-involved liaisons to analyze the situation for possible impacts on their units.
  - d. Send size, activity, location, unit identification, time, and equipment (SALUTE) report to higher headquarters (HQ).
  - e. Update G-3 and/or chief of current operations integration cell with information from liaisons or higher HQ.
3. Chief of current operations integration cell or G-3, in accordance with unit SOP, performs the following actions:
  - a. Communicate attention in the command post (CP) and announce the civil disturbance
  - b. Inform commander, chief of staff (COS), and executive officer (XO).
  - c. Conduct a hasty mission analysis to identify courses of actions and priorities that:
    - (1) Integrate the intent of the commander.
    - (2) Identify critical socio-cultural impacts to operations.
    - (3) Determine availability of unmanned aerial system (UAS) or other reconnaissance assets to increase situational awareness.
    - (4) Determine host nation and local law enforcement/security forces capabilities concerning their rules of engagement.
    - (5) Determine what group is causing the civil incident, what the group's goals and capabilities are, and what is the group's leader's role.
    - (6) Identify assembly areas and security measures.
    - (7) Identify security measures for key facilities/critical assets (friendly and host nation (HN)).

(8) Identify the group's most likely and most dangerous courses of action.

(9) Determine actions needed to resolve the incident peacefully and within the commander's intent, HN and international law, and the desired end-state.

4. The staff contributes to hasty mission analysis and planning:

a. Performs parallel coordination and planning with the division provost marshal office (PMO) and other military police (MP) assets.

b. Confirms rules of engagement (ROE) for outside of the continental United States (OCONUS) and rules on the use of force (RUF) for inside the continental United States (CONUS) with the staff judge advocate (SJA).

c. Obtains legal guidance from the SJA on operational mandates, status-of-forces agreements, status-of-mission agreements, and other restrictions.

d. Confirms availability of lethal and nonlethal ammunition and control agents.

e. Identifies the reserve or response forces, medical evacuation areas, and detained person holding areas.

\* 5. The staff briefs the commander, COS, and/or XO on the courses of action.

\* 6. Commander, COS, and/or XO provides guidance on operations to the chief of current operations integration cell or G-3.

\* 7. Chief of current operations integration cell or G-3 disseminates the commander's guidance and supervises execution of guidance.

8. The chief of the protection cell conducts analysis to identify additional command post survivability changes are necessary.

## TASK MEASURES

  3. Chief of current operations integration cell or G-3, in accordance with unit SOP, performed the following actions:
    - Communicated attention in the command post (CP) and announced the civil disturbance.
    - Informed commander, chief of staff (COS), and executive officer (XO).
    - Conducted a hasty mission analysis to identify courses of actions and priorities that:
      - o Integrated the intent of the commander.
      - o Identified critical socio-cultural impacts to operations.
      - o Determined availability of unmanned aerial system (UAS) or other reconnaissance assets to increase situational awareness.
      - o Determined host nation and local law enforcement/security forces capabilities concerning their rules of engagement.

**d.Explanation:** Refer to performance measures and explain what each staff member must do to react to a report of civil disturbance.

**e.Unit Instructions:** The Staff is coordinating current operations and receives a report of civil disturbance within the area of operations.

**Walk:**

**Run:**
