The team is issued a fragmentary order (FRAGORD) or operation order (OPORD) assigning it to debrief U.S. or allied personnel who have escaped or evaded capture. The team has the commanders priority intelligence requirements (PIR). Interpreter(s) or automated translation capabilities are available. The team has communications with subordinate units, adjacent units, and higher headquarters. The mission command and intelligence systems are operational and processing information. The team has the unit standard operating procedures (SOP). Some iterations of this task should be performed in MOPP 4.

STEP/MEASURE

+ 1. The HUMINT operations management team task organizes HUMINT collection teams (HCT) as directed by the OPORD, or FRAGORD.

a. Prioritizes HUMINT collection missions.

b. Directs the assignment of HCT to debrief of U.S. or allied personnel.

(1) Assigns debriefing tasks to the teams.

(2) Identifies critical collection criteria.

(3) Provides the focus for collection to the teams

c. Supervises HCT mission preparation.

(1) Advises teams on tactics, techniques, and procedures (TTP) for debriefing tasks.

(2) Directs rehearsals of team missions.

(3) Directs teams to conduct pre-combat checks and inspections.

2. The HCT prepares to conduct the debriefing.

a. Coordinates with the supported unit to establish a debriefing area.

b. Ensures debriefing location is a secure area, out of sight and sound, from other personnel.

c. Coordinates with the supported unit to establish a holding area for persons requiring further questioning.

d. Determines allied personnel interpreter requirements for language, fluency, and necessary security clearance.

e. Requests from the supported unit an assessment of attitude and behavior of each source.

f. Examines all documents and materials associated with each source.

g. Develops initial and follow up questions to identify sources who could provide information answering intelligence requirements.

+ 3. The HCT conducts the debriefing of U.S. or allied personnel.

a. Obtains basic contact information from the U.S. or allied source.

(1) Military unit assigned to prior to separation from the unit.

- (2) Military occupational specialty.
- (3) Circumstances resulting in separation from the unit.

(4) Other information that the source voluntarily discloses.

b. Determines if the source has information that answers intelligence requirements.

(1) Records all information provided by the source.

(2) Determines the type of information the source reports.

(3) Uses effective follow-up questions to expand on initial answers.

(4) Interjects non-pertinent, repeat, and control questions to test source answers.

(5) Thoroughly debrief source on all areas of information relevant to collection requirements.

c. Questions the source on their observations concerning the operational environment.

(1) Contact or observation of threat forces.

(2) Attitudes of the civilian populace.

(3) Differences in the mission environment.

d. Determines the specific circumstances leading to the escape or evasion from capture of the source.

(1) Determines source observations of enemy methods of operations.

(2) Determines observations on enemy intentions.

(3) Identifies threat prisoner of war (POW) handling and interrogation methods.

(4) Determines observed enemy weaknesses

(5) Obtains information concerning other friendly POW not returned.

(6) Identifies battle damage observed by subject.

4. The HUMINT team prepares assessments and reports of the debriefing IAW the SOP.

a. Develops a SALUTE report for the supported unit if PIR information is obtained.

b. Submits a completed debriefing report for each source debriefed.

Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW current CBRN doctrine.
