Condition: The unit is engaged in Full Spectrum Operations. All CPs, TOCs, and Command Centers are operational and can send and receive reports and overlays. The commander has given his guidance and specified his intent and that of the next higher commander. The commander has issued his critical information requirements (CCIR). You have come to provide religious support and pastoral care to a mixture of units who are about to, are currently, or recently have been deployed. Some have sustained several casualties. Some are new recruits. Some are experienced veterans. Family members may or may not be present. Some iterations of this task should be performed in MOPP 4.

Standard: The UMT provides pastoral care and counseling, and instruction on ethics, resiliency, culture and religion, and family issues through classes, study groups, meetings, discussions, and by making available religious education materials and curriculum IAW Garrison or Tactical SOP, RS Annex, RS Matrix, the MASCAL Plan, and procedures directed by command and/or described in FM 1-05, to include all coordination and reporting to the command and next higher UMT, while maintaining confidentiality at all times.

Task Statements

Cue: There is a requirement to conduct religious support for a unit conducting military operations.

DANGER

Leaders have an inherent responsibility to conduct Composite Risk Management to ensure the safety of all Soldiers and promote mission accomplishment.

Refer to FM 3-34.5 Environmental Considerations and GTA 05-08-002 ENVIRONMENTAL-RELATED RISK ASSESSMENT. Environmental protection is a continual process. Always be alert to ways to protect our environment and reduce waste.

Safety: In a training environment, leaders must perform a risk assessment in accordance with ATP 5-19, Risk Management. Leaders will complete the current Deliberate Risk Assessment Worksheet in accordance with the TRADOC Safety Officer during the planning and completion of each task and sub-task by assessing mission, enemy, terrain and weather, troops and support available-time available and civil considerations, (METT-TC). Note: During MOPP training, leaders must ensure personnel are monitored for potential heat injury. Local policies and procedures must be followed during times of increased heat category in order to avoid heat related injury. Consider the MOPP work/rest cycles and water replacement guidelines IAW FM 3-11.4, Multiservice Tactics, Techniques, and Procedures for Nuclear, Biological, and Chemical (NBC) Protection, FM 3-11.5, Multiservice Tactics, Techniques, and Procedures for Chemical, Biological, Radiological, and Nuclear Decontamination. Everyone is responsible for safety. A thorough risk assessment must be completed prior to every mission or operation.
